BE IT FURTHER RESOLVED, that the expenditure of \$3,500 is hereby authorized from Park and Recreation Bond Fund 725, solely and exclusively, for the design, construction and related expenses of the above-referenced project and supplementing Resolution No. 213951 in this amount.
