

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with LOWRY AND ASSOCIATES to increase the maximum allotted compensation for consultant engineering services for the Metropolitan Sewerage System Planning Study (EPA Step 1 Project) and the Environmental Impact Report, under the terms and conditions set forth in the form of First Amendment to Agreement on file in the office of the City Clerk as Document No. 753909.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within Sewer Revenue Fund 506 the sum of \$54,794.00 from the Unallocated Reserve 69.97-3485 to 69.42-3293 for the sole and exclusive purpose of providing funds for said services.
