That Change Order No. 1, dated November 19, 1975, heretofore filed with the City Clerk of said City as Document No. 753907, issued in connection with the contract between The City of San Diego and C & H Equipment Rentals, for the slope restoration for BALBOA PARK GOLF COURSE, said contract having been filed in the office of the City Clerk as Document No. 752378, be and the same is hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$5,000 and an extension of time of 90 days extending the completion date to January 26, 1976, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$8,500 is hereby authorized from Capital Outlay Fund 245, solely and exclusively, for construction, supervision and management of the above-referenced project.
