That the expenditure of \$197,470.00 is hereby authorized from Gas Tax Funds (Fund No. 220) and that the expenditure of \$48,500.00 is hereby authorized from Capital Outlay Fund (Fund No. 245) Reserve of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF A PEDESTRIAN OVERPASS - TORREY PINES ROAD AT LA JOLLA SHORES DRIVE, including Addenda A and B, in the City of San Diego, and related costs.
