APPROVING MAP OF RIO LAND SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, entitled "RIO LAND SUBDIVISION Being a subdivision of Lot 1 of Idaho Subdivision, according to Map thereof No. 4689, filed in the office of the County Recorder of San Diego County, January 12, 1961, and a portion of Pueblo Lot 1112 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, filed in the Office of the County Recorder of San Diego County, November 14, 1921, all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, a permanent easement for open space upon a portion of Lot 2, as granted and shown on said map and subject to the conditions as set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and


