APPROVING MAP OF LA JOLLA ALTA PRD UNIT NO. 2
SUBDIVISION AND ACKNOWLEDGING RECEIPT OF
SUBDIVIDER'S ASSURANCE OF COMPLIANCE WITH THE
AFFIRMATIVE MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by W. R. NOTHOMB, Licensed Surveyor, entitled "LA JOLLA
ALTA PRD UNIT NO. 2 Being a subdivision of a portion of
Pueblo Lot 1780 of the Pueblo Lands of San Diego, in the
City of San Diego, County of San Diego, State of California,
according to Map thereof made by James Pascoe in 1870, a copy
of said Map was filed in the Office of the County Recorder of
San Diego County, November 14, 1921, and is known as Miscell-
aneous Map No. 36.", is made in the manner and form prescribed
by law and conforms to the surrounding surveys; that said map
and the subdivision of land shown thereon is hereby approved
and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, the easements listed in
paragraphs 1, 2 and 3 of the Owner's certificate, as shown
on this map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed
to endorse upon said map, as and for the act of the Council,
that said Council has approved said subdivision map and that


