WHEREAS, the value of the property right sought, as determined by a staff appraiser of said City, is the sum of Thirty-Two Dollars and Fifty Cents (\$32.50); and

WHEREAS, no real estate broker's commission shall be paid; and

- 4. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
