

**RESOLUTION No. 215127**


Adopted on JAN 21 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of TITLE INSURANCE AND TRUST COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of December 2, 1975, conveying to said City the permanent easement and right of way to construct, reconstruct, maintain, operate and repair a storm drain or drains affecting a portion of Pueblo Lot 1780 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, a copy of which map was filed in the Office of the County Recorder of San Diego County on November 14, 1921 and is known as Miscellaneous Map No. 36, as more particularly described in said deed, be and the same is hereby approved.

That the City Clerk is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
