

RESOLUTION No. 215129


Adopted on JAN 21 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of RICHARD A. and MICHALYN L. CROWTHER, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of December 12, 1975, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Lot 75 of Boulevard Gardens, according to Map thereof No. 1505 filed in the office of the County Recorder of San Diego County, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named VEGA STREET.

That the City Clerk is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the Office of the County Recorder of San Diego County.
