BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of RAMON CISNEROS MORALES, a widower, executed in favor of The City of San Diego, bearing date of November 25, 1975, conveying to said City for public street purposes a portion of Section 35, Township 18 South, Range 2 West, San Bernardino Base and Meridian, according to United States Government Survey, approved February 25, 1870, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named BEYER BOULEVARD.

That the expenditure of not to exceed \$15,000 from Gas Tax Fund 220 is hereby authorized for acquisition of the above described property.

That the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
