That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Tideland Use and Occupancy Permit with the SAN DIEGO UNIFIED PORT DISTRICT, whereby City leases approximately 18,500 square feet for the purpose of vehicle parking for the San Diego Police Department located directly across Kettner Boulevard from the Police Station, south of the Wosk Building, at a monthly rental of \$308, for a term of one year, under the terms and conditions set forth in the form of permit on file in the office of the City Clerk as Document No. **754032**.
