RESOLUTION NO. 215146

WHEREAS, on July 1, 1974, The City of San Diego entered into a 50-year lease with the San Diego Unified School District for the operation of Balboa Stadium and Section 23 of said lease states that the School District cannot allow any professional sports franchises to use Balboa Stadium without the City Council adopting a resolution which specifically authorizes such use; and

WHEREAS, the School District has requested the City Manager to allow professional soccer games of the American Soccer League and the North American Soccer League in the stadium; and

WHEREAS, at the present level of popularity of professional soccer, and in view of the limited seating capacity of Balboa Stadium, these games do not constitute serious competition to the successful operation of either the Sports Arena or San Diego Stadium; and

WHEREAS, it is desirable to reserve the right to revoke the Council's authorization of such use at any time by giving at least one years prior written notice of intent to revoke; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the San Diego Unified School District is hereby authorized to rent Balboa Stadium for professional soccer.


