WHEREAS, pursuant to an agreement entered into between City and Foundation dated December 10, 1975, Foundation provided the American Freedom Train for exhibition in the City of San Diego; and

WHEREAS, said event took place during the period of January 14 through January 18, 1976; and

WHEREAS, a great number of persons availed themselves of the opportunity to view the American Freedom Train during the period between January 14 and January 18, 1976, but some of those who desired to view the train and purchased tickets therefor were unable to avail themselves of the opportunity because of logistic problems and weather conditions; and

WHEREAS, City and Foundation desire to reimburse those persons who were unable to avail themselves of this opportunity because of the aforesaid conditions; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with the AMERICAN FREEDOM TRAIN FOUNDATION, INC., under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 754023.

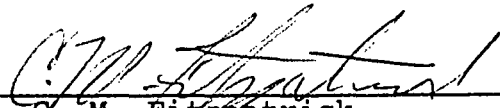

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$3,000 is hereby authorized from the Transient Occupancy Tax Fund 224 for the sole and exclusive purpose of providing funds for the reimbursement of shuttle bus ticketholders.
