
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with GEORGE S. NOLTE AND ASSOCIATES for engineering services for the Catalina Pump Plant project, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 754107.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within Water Revenue Fund 502 the sum of \$2,452 from the Unallocated Reserve (69.97) to C.I.P. Project No. 72-049; and the expenditure of not more than \$22,452 is hereby authorized from Water Revenue Fund 502 (Project No. 72-049) for the sole and exclusive purpose of providing funds for the above engineering services.
