

RESOLUTION NO. 215203 JAN 28 1976

WHEREAS, the City Council of San Diego has previously authorized the City Manager to execute an agreement with The Atchison, Topeka and Santa Fe Railway Company for the reconstruction of the spur track crossing of MIRAMAR ROAD pursuant to Resolution No. 213046; and

WHEREAS, Resolution No. 213046, adopted April 17, 1975, contained an authorization for \$20,000 to be expended for the purposes of that reconstruction; and

WHEREAS, the right of way is now available to construct the crossing protection devices in their ultimate location;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with The Atchison, Topeka and Santa Fe Railway Company regarding the widening of Miramar Road at PUC Crossing No. 2-253.80-C, and the maintenance of railroad crossing protection signals at said crossing, in the City of San Diego, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 754114.



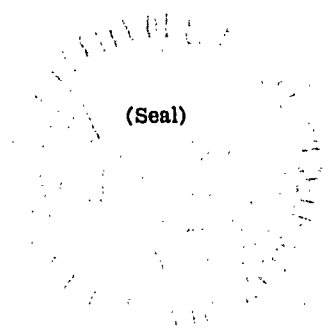
