

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, UTILITIES AGREEMENT NO. 18632 with the State Department of Transportation for relocation of sewer facilities on Interstate 5 between 0.2 mile south of 8th Street in National City and 0.1 mile north of Chollas Creek in San Diego; and on Route 15 between Interstate 5 and Imperial Avenue, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 754119.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within the Sewer Revenue Fund 506 the sum of \$190,977 from the Unallocated Reserve (69.97) to Sewer C.I.P. City Force and Contract (64.92); and the expenditure of \$504,943 is hereby authorized out of Sewer Revenue Fund 506 for the sole and exclusive purpose of providing funds for said project.
