

RESOLUTION NO. 215219 JAN 28 1976

WHEREAS, The City of San Diego, California has entered into a contract with the United States Department of Housing and Urban Development (HUD) to carry out, within The City of San Diego, a Housing and Community Development Block Grant Program; and

WHEREAS, the City Council of The City of San Diego, by Ordinance No. 10954 (New Series) adopted November 21, 1972, adopted a Redevelopment Plan for the Linda Vista Shopping Center Redevelopment Project; and

WHEREAS, the purpose of said Redevelopment Plan is to create a modern neighborhood shopping center meeting the needs of the surrounding community, as well as providing residential development; and

WHEREAS, the execution of said Redevelopment Plan would promote the public peace, health, safety, and welfare of The City of San Diego; and

WHEREAS, the City Council on November 26, 1974 by Resolution No. 212090 allocated \$230,468 for commercial development from The City of San Diego's First Block Grant application; and

WHEREAS, the City Council on October 9, 1975 by Resolution No. 214434 allocated \$110,000 for community development from The City of San Diego's Second Block Grant application; and

WHEREAS, the successful implementation of the Linda Vista Redevelopment Project requires the use of additional Block Grant funds in the estimated amount of \$605,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


1. That the City Auditor be and he is hereby authorized, for the purpose of implementing the Linda Vista Redevelopment Project, to transfer the sum of \$230,468 from Community Development Block Grant Fund No. 2910 to Redevelopment Fund No. 985 as an advance to be repaid from tax increment or other project revenues.

2. That the City Auditor be and he is hereby authorized, for the purpose of implementing the Linda Vista Redevelopment Project, to transfer the sum of \$110,000 from Block Grant Fund No. 290 to Redevelopment Agency Fund No. 985 as an advance to be repaid from tax increment or other project revenues. Said transfer of funds is contingent upon approval by the Department of Housing and Urban Development (HUD) of The City of San Diego's Second Program Year Block Grant application.

3. That the City Auditor be and he is hereby authorized, for the purpose of implementing the Linda Vista Redevelopment Project, to transfer the sum of \$605,000 from the contingency reserve of Fund No. 290 to Redevelopment Agency Fund No. 985 as an advance to be repaid from tax increment or other project revenues. Said transfer of funds is contingent upon approval by the Department of Housing and Urban Development (HUD) of The City of San Diego's Second Program Year Block Grant application.

4. That the Scope of Services, Budget, and Work Program, as set forth in the documents on file in the office of the City Clerk as Document No. 754139, be and the same are hereby approved.
