

RESOLUTION No. 215220Adopted on JAN 28 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an Assignment with ECONOMIC DEVELOPMENT CORPORATION, whereby EDC assigns to City all its rights contained in that certain deed executed by EDC as Grantor to Kyocera International, Inc., as recorded on April 17, 1974 as File No. 74-096307, Official Records of San Diego County, the form of which assignment is on file in the office of the City Clerk as Document No. 754140.

2. That the acceptance by the City Manager of that deed of KYOCERA INTERNATIONAL, INC., a California corporation, executed in favor of The City of San Diego, bearing date of December 22, 1975, conveying to said city Lot 1 of City of San Diego Industrial Park Unit No. 1, as more particularly described in said deed, be and the same is hereby approved.

3. That the expenditure of \$709,174 from Trust Fund No. 314 is hereby authorized solely and exclusively for the purpose of re-purchasing of the above described property.
