

RESOLUTION No. 215223


Adopted on JAN 28 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of TITLE INSURANCE AND TRUST COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of December 2, 1975, conveying to said City the permanent easement and right of way for a public street and incidents thereto over, under, upon, along and across portions of Pueblo Lots 1775 and 1780 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, a copy of said Map was filed in the Office of the County Recorder of San Diego County on November 14, 1921, and is known as Miscellaneous Map No. 36, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcels A and B are hereby dedicated as and for a public street and the same is hereby named CARDENO DRIVE; and the land therein conveyed as Parcel C is hereby dedicated as and for a public street and the same is hereby named ALTA LA JOLLA DRIVE.

That the City Clerk is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the Office of the County Recorder of San Diego County.
