RESOLUTION NO. 215230

WHEREAS, FRANK A. AZZINARO and WAYNE R. YOCUM, JR., dba Chair There, have applied to the City Council for two Certificates of Public Convenience and Necessity to operate automobiles for hire within the limits of the City of San Diego; and

WHEREAS, pursuant to Section 72.0204 of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council, which report indicates:

A. There is a demand for this kind of service to the handicapped which is now provided by other carriers as an adjunct to their other activities.

B. The existing taxicab and Dial-A-Ride services can provide a similar service as that proposed; however, those agencies do not provide a service that is solely designed for the handling of wheelchair clientele.

C. The applicants are financially responsible. They have no past experience in the transportation field.

D. The vehicles proposed for use are two double-sportsman vans. A complete inspection for public safety requirements will be made prior to their operation for hire, should the certificates be issued.


E. The Traffic Engineer reports the proposed service will not have an effect on the traffic congestion and parking.

YOCUM, JR., dba Chair There, having filed an application for two Certificates of Public Convenience and Necessity to operate two vehicles for hire pursuant to the provisions of Section 72.0202 of the San Diego Municipal Code, and the City Manager having conducted the required investigation, the Certificates of Public Convenience and Necessity are hereby granted to FRANK R. AZZINARO and WAYNE R. YOCUM, JR., dba Chair There, to operate the vehicles specified in the application subject to compliance with all provisions of the San Diego Municipal Code.
