2. That the expenditure of \$28,000.00 is hereby authorized from Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for FIRE STATION NO. 28 - REPAIR FACILITY OFFICE, Schedule II, in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$2,000.00 from CIP No. 33-051 to Capital Outlay Fund Reserve, CIP No. 90-245.
