

RESOLUTION No. 215253Adopted on **FEB 4 1976**


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of J. DENNIS ORD and CONNIE L. ORD, his wife, executed in favor of The City of San Diego, bearing date of December 30, 1975, conveying to said city for street purposes a portion of Section 23, Township 18 South, Range 2 West, S.B.B.M., as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named BEYER WAY.

That the expenditure of not to exceed \$23,300 from Gas Tax Fund 220 is hereby authorized to cover acquisition costs of the above described property.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
