


RESOLUTION No. 215255Adopted on FEB 4 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of WILLIAM T. and DORIS RAY, husband and wife as joint tenants, as to an undivided one-half interest; and LLOYD B. and ELIZABETH A. HART, husband and wife as joint tenants, as to an undivided one-half interest, as tenants in common, executed in favor of The City of San Diego, bearing date of January 4, 1976, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Lots 57 and 58 of Highdale Addition to Encanto Heights, according to Map thereof No. 1176 filed April 20, 1909, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named RADIO DRIVE.

That the City Clerk is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
