BE IT FURTHER RESOLVED, that the expenditure of \$3,360 is hereby authorized from Park and Recreation Bond Fund 725, solely and exclusively, for design, construction and related expenses of the above-referenced project and that Resolution No. 213045 be and the same is hereby supplemented in this amount.
