APPROVING MAP OF LA JOLLA ALTA P.R.D. UNIT NO. 5
AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE
OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING PROGRAM

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by W. R. NOTHOMB, Licensed Land Surveyor, entitled "LA JOLLA
ALTA P.R.D. UNIT NO. 5 Being a subdivision of portions
of Pueblo Lots 1775 and 1780 of the Pueblo Lands of San Diego,
in the City of San Diego, County of San Diego, State of
California, according to Map thereof made by James Pascoe
in 1870, a copy of said Map was filed in the Office of the
County Recorder of San Diego County, November 14, 1921,
and is known as Miscellaneous Map No. 36.", is made in the
manner and form prescribed by law and conforms to the
surrounding surveys; that said map and the subdivision of
land shown thereon is approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, the easements listed in
paragraphs 1 and 2 of the Owner's certificate, as shown on
this map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby
acknowledges receipt of assurance from the subdivider,
TECHBILT CONSTRUCTION CORP., a California corporation, that
said subdivider will comply with the Affirmative Marketing
Program as outlined in Document No. 745744, on file in the
office of the City Clerk, and in reliance on said assurance
does hereby accept the final map of LA JOLLA ALTA P.R.D.
UNIT NO. 5.


