APPROVING MAP OF ROSENBERG SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by ROGER L. SNIPES, Registered Civil Engineer, entitled "ROSENBERG SUBDIVISION Being a subdivision of a portion of Lot 63 of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to Partition Map thereof on file in the Office of the County Clerk of said County, in the action entitled "Juan M. Luco, et al, vs. Commerical Bank of San Diego, et al, being action No. 348 of the Superior Court, together with a portion of Old Cliffs Road as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Mission Gorge Road and a portion of Old Cliffs Road for public purposes; and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication that portion of Lot 1, marked "Reserved for Future Street," as shown on this map, under the provisions of Section 66440 of the Government Code.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement and right-of-way for the natural flowage of waters over, upon and across that portion of Lot 1, marked "Flowage Easement," as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of public streets are accepted on behalf of the public as heretofore stated; and that that certain easement for water flowage as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated; and said Council has rejected a portion of Lot 1, marked "Reserved for Future Street," shown on this map within this subdivision, all as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
