BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an Agreement To Terminate Incineration Service Agreement with SAN DIEGO GAS & ELECTRIC COMPANY, a California corporation, for the experimental operation of a gas turbine power plant for the production of electrical energy utilizing sludge gas as fuel, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 754234; provided that:

(1) San Diego Gas & Electric Company be requested to provide the City with all technical data accumulated from the joint venture at the Point Loma site.

(2) The City undertake a thorough investigation of old and new technologies in the use of sludge gas to generate usable power.

(3) The experience and plans of other cities as regarding the productive use of sewage sludge gas be analyzed and evaluated.
