

RESOLUTION NO. 215268

FEB 4 1976

WHEREAS, The City of San Diego has realized significant savings since becoming self-insured in 1970 for public liability risks; and

WHEREAS, the other twelve cities in San Diego County currently insure for such risk, but the costs are becoming prohibitively expensive; and

WHEREAS, through a pooled, intergovernmental approach, it is believed that the City can realize additional savings in administrative and excess insurance coverage costs and can significantly reduce insurance costs for the other twelve cities; and

WHEREAS, the County-City Manager's Association has proposed an intergovernmental cooperative risk management approach as a significantly less costly alternative to insuring each individual city's municipal liabilities; and

WHEREAS, the Federal Government, in cooperation with the State of California, is providing an opportunity for local jurisdictions to fund projects via discretionary monies which demonstrate substantial cost savings and multijurisdictional coordination; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby fully authorized and empowered to submit, for and on behalf of said City, a grant

application to the United States Civil Service Commission,  
Bureau of Intergovernmental Personnel Programs, for funds in  
the amount of \$20,000 to be used to conduct a Risk Management  
Feasibility Study in cooperation with the other twelve cities  
in San Diego County.

BE IT FURTHER RESOLVED, that the City Manager be and he is  
hereby further authorized to execute the above grant agreements  
upon receipt of said grant offer documents from the United States  
Civil Service Commission.
