WHEREAS, under the provisions of Council Policy 700-4, Balboa Park Leases and Rentals, the City is to recover from those organizations not exempt from rental charges, as a minimum, an amount sufficient to provide for the direct costs of operation of Balboa Park buildings and facilities as determined by the City Manager; and

WHEREAS, under the existing rental schedule adopted in 1948 and 1954, the average amount charged for the use of said buildings and facilities is one-third (1/3) cent per square foot per use; and

WHEREAS, as of March 1, 1975, it costs the City approximately two and one-half (2 1/2) cents per square foot per use to operate the buildings and facilities in Balboa Park; and

WHEREAS, on August 19, 1975, the Park and Recreation Board recommended approval of the revised rental fees; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized and empowered to revise the rental rates for Balboa Park buildings and facilities upward to a base rate of two and one-half (2 1/2) cents per square foot per use.

RESOLUTION NO. 312270 FEB 4 1978

WHEREAS, by Resolution No. 31472 the City Council authorized an agreement between The City of San Diego and the San Diego Urban League, Inc., for the purpose of operating the Young Mothers Project from December 1, 1975 through June 30, 1976, at a budget not to exceed \$28,352; and

WHEREAS, on December 31, 1975, the Public Services and Safety Committee of the San Diego City Council approved an additional budget increase of \$30,000 for the purpose of expanding the project operations to two new sites located in Linda Vista and San Ysidro; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with the SAN DIEGO URBAN LEAGUE, INC., for the purpose of expanding the operations of the Young Mothers Project to acceptable sites in the Linda Vista and San Ysidro communities, and further authorizing the expenditure of up to \$30,000 for this purpose, pursuant to the terms and conditions set forth in the form of First Amendment to Agreement on file in the office of the City Clerk as Document No. 754239.
