


RESOLUTION No. 215273Adopted on FEB 4 1976

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an Agreement with the BANK OF AMERICA NATIONAL TRUST AND SAVINGS ASSOCIATION, a national banking association, whereby the Bank of America will process, authorize and service property rehabilitation loans, under the terms and conditions set forth in the form of Agreement on file in the office of the City Clerk as Document No. 754247.

That the expenditure of not to exceed \$200,000 from Community Development Block Grant Fund 2910. to provide funds for the above agreement is hereby authorized and approved.
