BAJO, husband and wife, executed in favor of The City of San Diego, bearing date of September 3, 1975, conveying to said City a portion of Section 27, Township 18 South, Range 2 West, San Bernardino Base and Meridian, according to United States Government Survey filed February 25, 1870, as more particularly described in said deed, be and the same is hereby approved.

That the expenditure of \$31,327 from Capital Outlay Fund 245 and \$66,173 from Park Service District 11-724 Fund, is hereby authorized for acquisition of the above described property and related expenses.

That the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
