RESOLUTION OF INTENTION NO. 215289

FEB 11 1976

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE THE ALLEY IN BLOCK 369 OF CORRECTED PLAT OF SUBDIVISION OF BLOCKS 368, 369, 374, 375, AND 376, OLD SAN DIEGO MAP NO. 420, AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of the alley hereinafter mentioned; and

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of the ALLEY in Block 369 of Corrected Plat of Subdivision of Blocks 368, 369, 374, 375, and 376, Old San Diego Map No. 420, as more particularly shown on Map No. 13646-B, on file in the office of the City Clerk as Document No. 754276.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 2:00 p.m., MAR 17 1976, in the Council Chamber on the twelfth floor of the City Administration Building, The Charles C. Dail Concourse, 202 C Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.

That The Daily Transcript, a daily newspaper published and circulated, and of general circulation, in the said City of San Diego, be, and it is hereby designated as the newspaper in which
