WHEREAS, the Engineering and Development Department has requested that the city quitclaim to TITLE INSURANCE AND TRUST COMPANY, a California corporation, the owner of the property, city's interest in and to said easements; and

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That that certain real property right described in that form of quitclaim deed on file in the office of the City Clerk as Document No. 754275, be, and the same is hereby authorized to be sold by negotiation for the sum of sixty-five dollars (\$65.00) to TITLE INSURANCE AND TRUST COMPANY, a California corporation.
- 2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 754275

 quitclaiming to TITLE INSURANCE AND TRUST COMPANY, a California corporation, certain easements for water purposes affecting a portion of Pueblo Lots 1780 and 1781, of the Pueblo Lands of San Diego, as more particularly described in said form of quitclaim deed.
- 3. That no broker's commission shall be paid by City on the herein-described negotiated sale.
- 4. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
