
Adopted on FEB 11 1976

That the expenditure of \$19,000 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively, for grading, drainage and miscellaneous improvements at PARADISE HILLS PARK AND RECREATION CENTER.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and empowered to undertake by means of City Forces, the grading, drainage and miscellaneous improvements in conjunction with the above-said project, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
