

RESOLUTION NO. 215318

FEB 12 1976

WHEREAS, pursuant to Charter Section 57, the City Manager recommended that William B. Kolender be appointed as Chief of Police; and

WHEREAS, Charter Section 57 requires that such appointment be confirmed by a majority of the City Council; and

WHEREAS, the Council adopted Council Policy No. 300-8 establishing a procedure for confirmation of appointment of the Chief of Police; and

WHEREAS, pursuant to Council Policy No. 300-8, the Public Services and Safety Committee (herein called Committee) conducted a public hearing on February 4, 1976 for the purpose of seeking community comments on the Chief of Police designate; and

WHEREAS, the Committee reported its findings to the Council and recommended unanimously that William B. Kolender be confirmed as Chief of Police; and

WHEREAS, Council Policy No. 300-8 provides that upon receipt of the Committee report, a special meeting of the City Council be called for the purpose of considering said confirmation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the findings and recommendations of the Public Services and Safety Committee relating to the confirmation of the Chief of Police be and the same are hereby acknowledged and adopted.


