2. That the expenditure of \$44,000.00 is hereby authorized from Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CENTRAL POLICE STATION - LABORATORY RECONSTRUCTION - PHASE II in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$9,000.00 from CIP No. 36-020(6) to Capital Outlay Reserve, CIP No. 90-245.
