BE IT RESOLVED, by the Council of The City of San Diego as follows: R76-1600

That the offer of Nixon-Egll Equipment Co. is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of FIVE (5) STREET SWEEPERS for a cost of \$33,738.00 each for a total cost of \$168,690.00; terms net 30 days plus sales tax less trade-in allowance of \$2,000.00 each for five (5) used street sweepers, with an option to purchase up to seven (7) additional street sweepers at the same price, terms and conditions until July 3, 1976, including trade-in's with single speed axle at \$1,000.00 each and sweepers with 2 speed axles at \$2,000.00 each.
