


RESOLUTION No. 215328Adopted on FEB 17 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the SAN DIEGO UNIFIED SCHOOL DISTRICT OF SAN DIEGO COUNTY, CALIFORNIA, executed in favor of The City of San Diego, bearing date of September 3, 1974, conveying to said City for street purposes a portion of Pueblo Lot 1233 of the Pueblo Lands of San Diego, according to the Map thereof made by James Pascoe in 1870, a copy of which was filed in the Office of the Recorder of San Diego County, November 14, 1921 and is known as Miscellaneous Map No. 36, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named KESLING STREET.

That the City Clerk is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
