

RESOLUTION NO. 215338

FEB 17 1976

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by city council resolution where those portions to be vacated have been superseded by relocation; and

WHEREAS, those portions of LAUREL STREET and CHOLLAS ROAD have been relocated by the approval on this date of the dedication of Perkon Place, Perkon Court, Euclid Court, Megan Way, Megan Court, and portions of Euclid Avenue by the acceptance of the final map of the subdivision to be known as Valley Park Estates; and

WHEREAS, those properties adjoining those portions of LAUREL STREET and CHOLLAS ROAD to be vacated will continue to have access or will be accessible by the streets which have been dedicated with the approval on this date of the subdivision to be known as Valley Park Estates; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That LAUREL STREET and CHOLLAS ROAD as more particularly shown on Drawing No. 13588-B, on file in the office of the City Clerk as Document No. 754365, which said drawing is attached hereto and made a part hereof, be and the same are hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
