WHEREAS, the Engineering and Development Department has requested that the city quitclaim to LARWIN-SOUTHERN CALIFORNIA, INC., a California corporation, its interest in and to said easements; and

WHEREAS, the sewer easements will be relocated into the street as required for proposed Encore Mira Mesa Unit No. 2 and grading will eliminate the need for the slope and drainage easement; and

WHEREAS, the city desires to negotiate the sale of said easements to LARWIN-SOUTHERN CALIFORNIA, INC., a California corporation, under the provisions of Section 22.0902 (e) of the San Diego Municipal Code, which permits the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such an interest in real property as this may reasonably be accomplished only by negotiation; and

WHEREAS, the value of the property rights sought, as determined by a staff appraiser of said city, is the sum of One Hundred Thirty Dollars (\$130); and

WHEREAS, no real estate broker's commission shall be paid; and WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

MICROFILMED MAY 23 1978 BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That that certain real property right described in that form of quitclaim deed on file in the office of the City Clerk as Document No. 754378, be, and the same is hereby authorized to be sold by negotiation for the sum of One Hundred Thirty Dollars (\$130) to LARWIN-SOUTHERN CALIFORNIA, INC., a California corporation.
- 3. That no broker's commission shall be paid by city on the herein-described negotiated sale.
- 4. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
