
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, an agreement with TOWERS, PERRIN, FORSTER AND CROSBY, actuaries for the City Retirement System, for the purpose of conducting an in-depth study at a cost not to exceed \$5,000 in order to provide the Council with an analysis of the feasibility of withdrawing from the Social Security System.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within the 100 Fund the sum of \$5,000 from the Unallocated Reserve (53.30) to the Allocated Reserve (53.20) to be used solely and exclusively for the above purpose.
