

BE IT RESOLVED, by The City of San Diego, that the area of planning responsibility of the Otay Mesa Planning Group is hereby expanded to include those portions of the City of San Diego bounded on the east by Interstate 5, the San Diego City limits on the west, Sunset Avenue on the south, and Main Street on the north.
