1. That the bid of \$329,957.50 by R.E. Hazard Contracting Co., a corporation, for IMPROVEMENT OF DEL SOL BOULEVARD - BEYER BOULEVARD TO I-805 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 753483.
2. That the expenditure of \$418,777.00 is hereby authorized from Gas Tax Funds (Fund No. 220) and that the expenditure of \$36,608.00 is hereby authorized from Capital Outlay Reserve (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF DEL SOL BOULEVARD - BEYER BOULEVARD TO I-805 in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$105,023.00 from CIP No. 52-190.2 to Gas Tax Unallocated Reserve, CIP No. 90-220.
