

RESOLUTION No. 215388Adopted on FEB 24 1976


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of L. C. SLATON and JODY C. SLATON, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of December 12, 1975, conveying to said city for street purposes a portion of Lots 39, 40, 41 and 42 in Block E of Alta Vista Suburb, according to Map thereof No. 1008 filed October 5, 1906 in the office of the County Recorder of San Diego County, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named 47TH STREET.

That the expenditure of not to exceed \$2,250 from Gas Tax Fund 220 is hereby authorized to cover acquisition costs of the above described property.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
