
Adopted on FEB 24 1976

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with NESTE, BRUDIN & STONE INCORPORATED for preparation of an Operation and Maintenance Manual for the Point Loma Wastewater Treatment Plant, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 754443.

BE IT FURTHER RESOLVED, that the expenditure of \$110,000 is hereby authorized out of Sewer Revenue Fund 506 (69.42 - 3293) for the sole and exclusive purpose of providing funds for the preparation of said Manual.
