

RESOLUTION No. 215392Adopted on FEB 24 1976


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an easement agreement with SAN DIEGO & ARIZONA EASTERN RAILWAY COMPANY, a Nevada corporation, to provide for the widening of PALM AVENUE, across the property of the railway company's crossing, under the terms and conditions set forth in the form of easement agreement on file in the office of the City Clerk as Document No. 754445.

BE IT FURTHER RESOLVED, that the expenditure of \$19,000 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for City's share to relocate track and upgrade the crossing to acceptable standards.
