

RESOLUTION No. 215397Adopted on FEB 24 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered, for and on behalf of said City, to enter into negotiations with the County of San Diego for the purpose of:

1. Continuing City support for those activities leading to the completion of the Comprehensive Health Care facility for a 6-month period (January 1, 1976 through June 30, 1976) to include provisions for pediatric and Senior Citizen Demonstration programs.

2. Participating in one-third net operational cost of the facility for a period from the opening of the Center and ending June 30, 1977, with the clear indication that the City will not participate in operational funding beyond that date and further, requiring a commitment from the County of San Diego to operate the facility after June 30, 1977.

3. Making available to the County for this purpose an amount up to but not exceeding \$700,000 from Community Development Block Grant Funds.
