

RESOLUTION No. 215401Adopted on FEB 24 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of TITLE INSURANCE AND TRUST COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of February 4, 1976, conveying to said city a portion of Lots 8, 9 and 10 in Block 2 of Crittenden's Addition, according to Map thereof No. 303, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named SIXTH AVENUE.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
