


RESOLUTION No. 215404Adopted on FEB 24 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of LENWOOD M. ALEXANDER and PAULINE ALEXANDER, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of December 3, 1975, conveying to said city a portion of Lot 9 in Block 6 of Brooks' Addition, according to Map thereof No. 596 filed in the Office of the County Recorder of San Diego County, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named SIXTH AVENUE.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
