


RESOLUTION No. 215416

Adopted on FEB 25 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$46,200 is hereby authorized out of Community Development Block Grant Fund 290 of The City of San Diego, solely and exclusively, for the continued financing of the SOCIAL PLANNING UNIT of the Human Resources Department in the amount of \$23,600 and for the COMMUNITY CENTER FOR STUDENT DEVELOPMENT in the amount of \$22,600, a continuing Model Cities Program, for a two-month period beginning March 1, 1976, or until final approval by Council of the Second Year Community Development Block Grant Program Budget, of which these projects are a part, whichever occurs first. Said programs shall be operated in accordance with the existing program format and in compliance with all federal guidelines and regulations for the expenditure of said funds.
